The committee will ensure that all legislative requirements as a registered charity in British Columbia are met and maintained.

The Finance Committee shall consist of the Treasurer and at least one Session member and at least two members of the congregation. Members of the Finance Committee will be approved annually by the Session. The minister or interim moderator will be an ex-officio member of the committee. The committee will choose its own Chair, excluding the Treasurer.
